## Town Board Minutes July 8, 2014

The monthly meeting of the Torrey Town Board held on July 8, 2014 at 56 Geneva St was called to order by Supervisor Flynn at 7:30PM.

Mr. Flynn led the pledge of allegiance.

Bob Brechko, YC Board of Election Commissioner appeared to discuss recent changes in elections process. Still in legislation is the bill to have all Federal state and local primaries run at the same time. This would lower cost for the county and area municipalities. He reported stats on voter registration, new, reinstated and dropped. Due to limited space issues, many polling places are being relocated. Town of Torrey may be moved to the Dresden Firehouse. All Milo districts will be moved to the Academy.

Mr. Flynn presented the abstracts of vouchers for audit.

Motion by Mr. Martini 2<sup>nd</sup> Mrs. Francisco, that the bills on the General A & B Funds in the amount of \$ 15366.58 be paid, carried by all.

Motion by Mr. Petersen, 2<sup>nd</sup> Mr. Morris that the bills on the highway DA & D Funds in the amount of \$ 33,051.77 be paid, carried by all.

Motion by Mr. Morris 2<sup>nd</sup> Mr. Petersen to approve the minutes of the June meeting carried.

Discussion on town park, mowing would be easier if the picnic tables were set on a concrete pads level with the ground. The village will supply the forms and set them up. A eyebolt will be placed in the concrete so the picnic tables can be secured to the pad. Summer rec has begun with attendance at 22 youth per day. Food Link is supplying lunch each day for the program. Clerk picks up lunches each morning at Milly's Pantry, on Fridays a back pack of food is sent home with each child for the weekends.

Jeff Finger gave the highway report. Working on footers for new bridge at Hopeton. Weighed old pipes deemed surplus. Each weighs @ 1 ton. He will check with salvage yard for steel prices then advertise for bids. Would like to hire part time help with the mowing. Highway crew is busy.

Dwight James gave the Code report. He issued 8 permits, 2 C of O, 1 Special Use Modification. 2 Site visits, 1 complaint, 9 building inspections, 1building condemnation, 9 other visits. 5 Safety Inspections at the camps and attended training at Yates County. 164 miles.

Town clean up days are set for July 26 & 27<sup>th</sup>.
